A. On 14 Dec 2011, the state announced a \$300,000 grant award to the Authority for the Phase 1 development of Whitehall Road Regional Park. The application for this grant was submitted in April 2011.

Including this grant, the Regional Parks Initiative has obtained \$1,028,000 in grant assistance for acquisition, planning and construction.

For all projects (pool renewals, regional parks, nature center), the total increases to \$2,916,705.

B. Information on the 2012 Grant Application Period has been announced by PA DCNR. While no regional grant applications are planned, the grant information has been relayed to the Municipal Managers for municipal park projects.
