CRPR reserves the right to revise or decline any proposed design that is not high enough resolution, that includes improper or offensive text or images, or otherwise does not fit with the mission of Centre Region Parks & Recreation. If the sponsor and CRPR cannot agree on a design after the second proof, CRPR maintains the right to issue a full refund, minus a \$25 Service Fee, and end the agreement.
