Each banner will be the property of Centre Region Parks & Recreation and will be produced, installed and maintained by the Agency, including refastening as needed. One replacement banner will be provided, if necessary, at no charge due to weather, vandalism or theft. The Agency reserves the right to revise or decline any proposed design that is not high enough resolution, that includes improper or offensive text or images, or otherwise does not fit with the mission of Centre Region Parks & Recreation. If the sponsor and the Agency cannot agree on a design after the second proof, the Agency maintains the right to issue a full refund, minus a \$25 Service Fee, and end the agreement.

Agreement is not complete until payment has been received. Credit cards can be taken over the phone at 814-231-3071 or in-person at the Centre Region Parks & Recreation main office. Checks can be made payable to "Centre Region Parks & Recreation Authority."

This agreement is executed by each party upon payment-in-full and expires October 31, 2022.
